Dear Attorney General Holder,

Who are these public health officials that propose such a monstrous act of torture of healthy children for a presumed health benefit". They should be named and held accountable like those who advocate torture as a policy of government. *The Ashley Montagu Resolution To End the Genital Mutilation of Children Worldwide: A Petition To The World Court, the Hague* affirms that the genital mutilation of children is a violation of the *United Nations Universal Declaration of Human Rights*; the *United Nations Convention on the Rights of the Child*; and other international covenants. The Montagu Resolution has received the support of Nobel Laureate Dr. Francis Crick; Dr. Jonas Salk, Founder. The Salk Institute for Biological Studies and many other leading citizen-scientists.

The *Universal Declaration on Circumcision, Excision, and Incision* was passed unanimously by *The First International Symposium on Circumcision (1989)*, which emphasized that circumcision pain returns in those rare cases where local anesthesia is used and remains a violation of the *United Nations Universal Declaration of Human Rights*, which states "No one shall be subjected to torture or to cruel, inhuman, degrading treatment or punishment".

It is well known that Federal Law establishes Female Genital Mutilation as a crime (PL 104-208), which was enacted on September 30, 1996 and the criminal provisions became effective on March 30, 1997. The 14<sup>th</sup> Amendment states "nor deny to any person within its jurisdiction the equal protection of the laws", which extends the criminal sanctions under PL 104-208 to male children. This reality has yet to be acknowledged by the Congress and it is requested that you formally act to assure this protection to male children. <http://mgmbill.org/usfgmlaw.htm>

Judge J. Flaherty (1978) in The Court of Common Pleas of Allegheny County, Pennsylvania. Civil Division. *McFall v Shimp* rendered his OPINION;

OPINION: "The question posed by the Plaintiff, is that, in order to save the life of one of its members by the only means available, may society infringe upon ones absolute right to his "bodily security."..."For a law to compel the Defendant to submit to an intrusion of his body would change every concept and principle upon which our society is founded. To do so would defeat the sanctity of the individual and would impose a rule which would know no limits and one could not imagine where the line would be drawn"..."Forceable extraction of living body tissue causes revulsion to the judicial mind. Such would raise the spectre of the swastika and the Inquisition, reminiscent of the horrors this portends... An Order will be entered denying the request for a preliminary injunction."

**An injunction against circumcision of male children that calls for the forceable removal of healthy penile tissue is requested and which is consistent with the principles of PL 104-208.**

It should be recognized that the studies purporting reduction of HIV/AIDS are fatally flawed as they have not controlled for personal genital hygiene; and that an explanation is needed why Zulus, who do not circumcise their teen-age boys, have the same infection rate as the Xhosa people who do circumcise. The development of an effective Medwipe with a microbiodical agent to neutralize the HIV would be as effective as circumcision in controlling HIV infections, as explained in my letter to Dr. Zerhouni of 23 January 2007. <http://www.violence.de/prescott/letters/Zerhouni-HIV-Circ.pdf>
